Monthly Returns to NILGOSC – i-Connect onboarding duties

This Circular sets out a reminder of the go live dates and duties for those employers who are not already onboarded to i-Connect

The implementation of this project to transition employers from a once yearly annual return to monthly returns has been very successful for employers to date. At this date 135 employers are now fully onboarded and using i-Connect as the portal to remit monthly member pay and contribution details. These employers no longer need to submit an annual return.

Go Live deadline reminder

As communicated in Circular 02/2025 issued on 29 January 2025, revised phases and implementation dates were issued for employers who are yet to be onboarded. These are set out in the Appendix. The majority of remaining employers are required to connect by **31 March 2026**. Thank you to employers who have commenced preparations for this change, working with our i-Connect team at NILGOSC to arrange payroll extracts and membership data matching. However, a number of employers have been unengaged in this process to date or have not made sufficient progress. Transition can be a lengthy process, and steps toward this need to be taken now in order to meet the Go Live date.

I would also like to draw your attention to the Employer Service Standards set out in the

Pension Administration Strategy. This outlines potential charges in relation to failure to

onboard to i-Connect (page 19). A copy of this Strategy can be found on our website:

Preparation duties

There are two main employer duties required to support the onboarding process:

Each employer will have been provided with a Payroll Extract Specification. This

should have already been forwarded to your payroll software provider and work

should be underway to create the extract file.

Each employer will be required to provide payroll extracts of membership data to the

NILGOSC i-Connect team for data matching to be undertaken. This will result in a

cycle of queries to cleanse and prepare the data.

Following these, the i-Connect team will fully train employer contacts in how to use the portal

during a supportive handover period.

Action: If you have not yet arranged for your payroll extract or commenced membership

data matching, please do so as soon as possible. Please respond to the latest

correspondence from the NILGOSC i-Connect team to commence this process. If you are

having difficulty carrying out these initial steps or require another copy of the Payroll Extract

Specification please contact i-Connect@nilgosc.org.uk.
